## MEETING NOTES

The SEPAC Board shared our Mission, Vision, Goals, survey results & upcoming meetings.

#### What is a SEPAC?

A Special Education Parent Advisory Committee serves as a representative body on behalf of students with special educational needs and their families. This is in accordance with the state's special education mandate: New Jersey Administrative Code 6A:14-1.2(h) which states,

"Each Board of Education shall ensure that a special education parent advisory group is in place in the district to provide input to the district on issues concerning students with disabilities." SEPAC in SOMSD was formed by a group of parents in 2012 and has been parent-led since its inception.

#### **Our Mission:**

In collaboration with the district and its commitment to excellence for all of our children, SEPAC SOMA will work for the understanding of, respect for, and support of every student with an Individualized Education Program, a 504 Plan or a special need in the South Orange & Maplewood School District. To that end, SEPAC SOMA will:

- Provide a forum to share and discuss matters of interest for parents or caregivers of students who receive special services.
- Provide input to the Board of Education and district administration on policies, programs and practices that impact students who receive special services.
- Advocate for the continual improvement of the district's programming as it relates to students with disabilities.

**SEPAC SOMA's Vision for the 2024-25 School Year** is for the South Orange & Maplewood School District to work in a proactive manner for students who need the greatest amount of support by intentionally engaging school and family partners resulting in an inclusive community for all learners.

## **SEPAC SOMA's 3 Primary Functions:**

- Collect data on systemic issues and best practices related to students with disabilities.
- Provide resources and tools to help parents and educators work collaboratively.
- Make recommendations and serve as an advisory partner to the BOE and School District.


### SEPAC SOMA Goals, 2024-2025

- Cup Chats with: teachers, students, 'veteran' parents.


- Partnership sessions with district & building administrators.

## My child/ren ... (if more than one child, check all that apply) 72 responses




## I'm interested in attending topic-based meetings (check all that apply) 72 responses




#### Topics I'm interested in learning more about

## **Introductions: Jason Bing and Kathleen Gesumaria**

#### Mr. Bing:

- Shared that the special education audit will be presented on Oct. 15th.
- The following BOE meeting they will share action steps from the audit and present a 3-5 year plan.
- Emphasized the importance of having a strong multi-tiered system of support.
- SOMSD is 2-4% above average classification rates for the state.
- Wants our district to be innovative and a leader in special education in the state

#### Dr. Gesumaria:

• Discussed her priority to have strong connection and collaboration between departments - C&I and Special Services working together and not thinking of our kids

in silos

- Has made in person visits to almost every school in first 3 weeks
- Wants all teachers to have solid reading toolbox and understand the science of reading
- More Orton Gillingham training
- More professional development (to come from internal staff)

## **Open Forum**

Parents voiced concerns about the following:

- Basic communication not happening parents don't have communication from case managers or know who their case manager is
- No home instruction at CHS
- PRISE not available in Creole
- No OT assigned to South Mountain
- 504 process massively challenging to navigate
- Students in self contained classes not feeling a part of their school community
- Students separated from older siblings being placed in different school due to inclusion class not being offered in all elementary schools
- Teachers not having enough support
